Please be advised that at its meeting held Wednesday, June 14, 2017, the Council of the Regional Municipality of Halton adopted the following resolution:

**RESOLUTION: LPS15-17 - Refusal of Regional Official Plan Amendment
Application - "An Amendment to Permit Surplus Farm Dwelling
Severances in Halton's Rural Area" (File: RQ58A)**

1. THAT staff be directed to prepare an amendment to the Halton Region Official Plan, for consideration in January 2018 at a meeting of Planning and Public Works Committee, to enable Local Municipalities in Halton Region to amend their Official Plans to permit the severance of a residence surplus to a farming operation for the purposes of farm consolidation provided that restrictions are put in place to limit the use of the remnant agricultural lot to Agricultural Purposes Only.
2. THAT the Halton Region Federation of Agriculture be requested to suspend the processing of Application RQ58A – An Amendment to Permit Surplus Farm Dwelling Severances in Halton's Rural Area.
3. THAT the Regional Clerk forward a copy of Amended Report No. LPS15- 17 to the City of Burlington, the Town of Halton Hills, the Town of Milton, the Town of Oakville and the Ministry of Municipal Affairs for their information..

Included please find a copy of Report No. LPS15-17 for your information. Please note that the resolution adopted by Council differs from the staff recommendation in the report.
