

Performance Measurement and Reporting

Performance measurement enables the Town to monitor and communicate about implementation, outcomes and impact of the actions taken to carry out the strategic plan. A new framework has been put in place to ensure regular ongoing management, monitoring and progress reporting in implementing the Strategic Plan.

The performance management framework's main elements include the formation of two special committees of Council:

- Growth and Infrastructure Committee
- Healthy Environment and Community Committee

The Special Committees meet quarterly and receive reporting which provides progress updates on identified initiatives from strategic priority champions. In addition, budgets and business plans remain the mechanism that define what gets worked on, resourced, funded and so on. That has not changed or stopped. The committees are designed to put a proactive transparent spotlight on what work is underway or planned to support the achievement of Council's Strategic Plan.

Communicating results

Effective communication of progress supports transparency and accountability. While evidence-based decision making may call for detailed, technical information, community reporting calls for simplified, accessible information.

The following information represents a community dashboard; an opportunity for the community to see what initiatives have been identified in support of Council's Strategic Plan along with how things are progressing. The following legend has been used to categorize progress and call out areas that may need attention or decision-making.


Icon Legend
