Preserving our heritage and enhancing our natural landscapes including special places such as Fairy Lake and Hungry Hollow.


# Safe & Welcoming Communities

Retaining our small town character while welcoming new residents, ensuring people are connected and expanding services and programs.



# **Taxpayer Information**



## **YOUR TAX BILL**

#### Retain your Tax Bill

Property taxes may be claimed when filing income tax. For payment confirmation, have your bill stamped with a payment receipt at Town Hall.



#### **Tax Bill Delivery Options**



Go paperless! Register for the new tax portal and sign up for email notifications when tax bills are added to your account.

Change your mailing address for tax bill delivery through the new tax portal or visit Town Hall to submit a change form.



#### Supplementary Tax Billings

Properties under construction or, being renovated or newly constructed may receive a supplementary tax bill after the Assessment Notice has been completed by MPAC. Supplementary or Omit notices are effective from the time of occupancy or the date of final inspection.



Recently moved? Ownership changes will be processed once the Town receives notification from MPAC, usually 3-5 weeks after the closing date. The Town will mail new homeowners a letter which includes your

property roll number, tax balance, and upcoming due dates.

### **Property Assessments**

The Municipal Property Assessment Corporation (MPAC) is responsible for determining the assessment class(es) and value(s) for each property in Ontario.

Add the Town as a payee (Halton Hills Taxes) and add your 19-digit number.




#### **Pre-Authorized Payment Plan**

Available at Town Hall by the front entrance. Payments must be received by end of business day on the due date to avoid late charges.
