



BY-LAW NO. 2023-0067

A By-law to amend the Town's Noise By-law No. 2010-0030 to amend the noise exemption process and to amend Schedule 'B'.

WHEREAS Section 102 of the *Municipal Act R.S.O. 1990, c. M.45* as amended permits every municipal council inter alia to pass such by-laws and make such regulations for the health, safety, morality and welfare of the inhabitants of the municipality in matters not specifically provided for by the Act as may be deemed expedient and not contrary to law:

AND WHEREAS Section 210(1) of the *Municipal Act R.S.O. 1990, c. M.45* as amended provides authority to Councils of municipalities to pass by-laws for regulating the keeping of animals or any class thereof within the municipality or defined area thereof;

AND WHEREAS on July 10, 2023, Council for the Town of Halton Hills approved Report No. ADMIN-2023-012, dated March 29, 2023, in which certain recommendations were made relating to the Town's Noise By-law 2010-0030.

NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:

1. Section 5.2 will be amended to read;

5.2 An application for an exemption under Part 5.1 shall be filed with the Designated Official and submitted on an application in the form prescribed by the Designated Official with payment as set out in the Town's Rates and Fees By-law and shall provide:

2. Section 5.2.9 will be amended to read;

5.2.9.1 No less than ten (10) days before the day of the hearing of the application for an exemption, Town staff shall send notification to the owner of neighbouring properties who may be impacted by the Noise by way of delivery of a written notice, by personal service or prepaid first class mail;

3. Section 5.2.11 will be amended to read;

Town staff shall provide public notification for two consecutive days no less than ten (10) days before the day of the hearing of the application in a newspaper of general circulation within the Town, of a notice of intention to apply for an exemption to the Noise provisions of this By-law, containing information required in Part 5, Section 5.2 thereof, and stating the date upon which application to Council is intended to be made.
