**BY-LAW NO. 2013-0062**

A By-law relating to the use, protection and regulation of Parks within the Town of Halton Hills and repeal By-laws No. 2003-0025 and 2005-0040

**WHEREAS** The Corporation of the Town of Halton Hills owns, operates and maintains Parks in the Town of Halton Hills;

**AND WHEREAS** Section 9 of the *Municipal Act, 2001*, S.O. 2001, c.25 provides a municipality the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

**AND WHEREAS** Section 11(3) of the *Municipal Act, 2001*, S.O. 2001, c.25, authorizes a municipality to pass by-laws respecting matters within the sphere of jurisdiction of culture, Parks, recreation and heritage;

**AND WHEREAS** Sections 23.1, 23.2, 23.3 and 23.5 of the *Municipal Act, 2001*, S.O. 2001, c.25 authorize a municipality to delegate certain powers and duties;

**AND WHEREAS** Sections 444 and 445 of the *Municipal Act, 2001*, S.O. 2001, c.25 provides that where a municipality is satisfied of a contravention of a by-law that the municipality may make an order to discontinue or correct the contravention of the by-law;

**AND WHEREAS** Section 446 of the *Municipal Act, 2001*, S.O. 2001, c.25 provides that where a municipality directs or requires by by-law or otherwise that a matter of thing be done, that in default of it being done by the person directed or required to do it, such matter or thing may be done at the person's expense and that the municipality may recover the cost of doing such thing or matter by action or by adding the costs to the tax roll and collecting them in the same manner as taxes;

**AND WHEREAS** on December 2, 2013, Council for the Town of Halton Hills approved Report No. R-2013-0045, dated October 22, 2013, in which certain recommendations were made relating to Parks By-Laws.

**NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:**

**PARKS BY-LAW**

**PART I DEFINITIONS**

1. In this By-law:

**Bicycle** includes a unicycle or tricycle but does not include a motor assisted cycle of any type;

**Boat** shall include any watercraft or other artificial contrivance, self-propelled or otherwise, used or capable of being used as a means of conveyance or transportation over water or ice surfaces;

**Department** means the Recreation and Parks Department of the Town of Halton Hills;

**Council** means the Council for the Town;

**Director** means the Director of the Recreation and Parks Department for the Town, or their designate;

**Leash Free Zone** means a designated area where licensed dogs may be unleashed pursuant to this By-law, and in accordance with the rules and regulations posted by the Director;

**Officer** means a police officer or municipal law enforcement officer or other person appointed by by-law to enforce the provisions of this By-law;

**Park** means any land and land covered by water, or premises within the Town used for Park or recreational purposes, including but not limited to green spaces, trails, Walkways, water features, natural areas, wooded areas and land cover and all portions thereof owned by or made available by lease, agreement or otherwise to the Town that is or hereafter may be established, dedicated or set apart or made available for use as public open space, including all buildings, structures, facilities and improvements located in or on such land;

**Parking Area** means an area that is physically laid out or improved for the purpose of parking Vehicles or that is designated by an official sign for such purpose within a Town Park;

**Person** includes a corporation, partnership, sole proprietorship, and service club;

**Permit** means the permission in writing, on a form signed by the Director authorizing an activity in a Park;

**Roadway** means an area that is designed for use by a Vehicle except where posted for Town or service Vehicles only;

**Swimming Area** means an area designated by the Director for swimming and bathing and includes lands and beaches designated as forming part of such area;

**Town** means The Corporation of the Town of Halton Hills;

**Trained Service Animal** includes a guide dog or other Trained Service Animal identifiable by a harness used principally to assist persons with a visual, hearing or other impediment as defined under the *Accessibility for Ontarians with Disabilities Act, 2005*;

**Vehicle** means a vehicle as defined under the *Highway Traffic Act, R.S.O. 1990, c.H.8*, as may be amended from time to time, and includes any carriage, wagon, sleigh, toboggan, or other vehicle or conveyance of every description, but does not include a baby carriage or cart, child's wagon, child's sleigh, child's stroller or other conveyance of like nature, wheelchair or other similar device used by an individual due to a disability;

**Walkway** means an area that is physically laid out or improved for a variety of users in a Park;

**Waste** means refuse, litter, garbage or anything that is discarded.

## **PART II SCOPE**

2. (1) The Parks of the Town are for the benefit and pleasure of all Persons who shall be subject to the rules and regulations passed thereto.
- (2) Properties set aside as a Park by the Town are to be used for the rest, recreation, pleasure, amusement, enjoyment and benefit of the public and it is desirable to prevent any person from interfering with the enjoyment by the public of such use.
- (3) Where a valid and subsisting Permit for the exclusive use of a Park or portion thereof, during the times and in the areas for which the Permit is granted, the holders of the Permit take precedent over casual use.
- (4) The provisions of this By-law shall apply to the Parks and recreational areas outlined in Schedule "A" attached hereto and forming part of this By-law, and to any other Park which may from time to time be acquired by the Town.
- (5) Park and recreation area users are subject to all applicable Municipal by-laws and all Provincial and Federal laws and regulations and all Persons contravening any by-law or law may be required to leave any Park or recreation area.

## **PART III ADMINISTRATION**

3. (1) The Director shall be responsible for the administration and enforcement of this By-law.
- (2) The Director shall:
  - (a) administer the management, control, regulations, maintenance, development and usage of all Parks within the Town;
  - (b) enforce the provisions of this By-law through the appropriate authorities;
  - (c) issue any necessary licences or Permits pursuant to the provisions of this By-law;
  - (d) recommend to Council, as required, from time to time revisions, additions or amendments to the By-law for the improvement to the management, control, regulations, maintenance, and usage of the Parks within the Town; and
  - (e) receive applications and provide recommendations to Council, as Council deems necessary, for festivals or special events taking place in Parks or using a Park.
- (3) The Director may, in writing, delegate any or all of the powers conferred on the Director by this Bylaw to any Person or Persons the Director considers advisable.

- (4) The Director may authorize the formalization and execution of contracts for:
  - (a) the operation of concessions in a Park, or in a building within a Park, selling anything or providing services deemed appropriate by the Director of Parks;
  - (b) the rental of equipment in a Park;
  - (c) the display or exhibit of information to the public in a Park;
  - (d) volunteers providing services to the Town, including any necessary indemnifications;
  - (e) related programs put on by the Department including leases and licences, and any necessary indemnifications; and
  - (f) the sponsorship of Department programs, events or other such items.
  
- (5) The Director may as the Director deems necessary for the administration of Town Parks, preservation and protection of Parks and amenities, and to ensure public safety:
  - (a) close, limit or restrict the use, or type of use of a Park, Walkway, pathway, trail, playground, sports field or facility or designated area;
  - (b) prohibit or vary any activity or use in a Park otherwise permitted pursuant to this Bylaw;
  - (c) establish or designate areas for the rest, recreation, pleasure, amusement, enjoyment and benefit of the public and the safe use of a Park; and
  - (d) cause signs to be erected describing any of the provisions of this by-law, or restricting or limiting the use or attendance on any part or portion of any Park for the interest of the public safety and well-being;
    - (i) In a prosecution for contravening this Bylaw the evidence that a sign was posted is prima facia proof that the sign was appropriately erected by the proper authority without other or further proof thereof.
  
- (6) The Director may grant Permits allowing any activity or use within a Park which is otherwise prohibited by this Bylaw, and upon review of an application or request the Director shall consider whether the activity or intended use:
  - (a) is incidental to the normal use and enjoyment of a Park;
  - (b) will encourage and develop leisure activities;
  - (c) will maintain the general intent and purpose of this By-law;
  - (d) will not contravene any other Town by-laws and all Provincial and Federal laws and regulations;
  - (e) will not be a nuisance or create an accident hazard; and
  - (f) will respect the health, safety and general welfare of the public.

- (7) The Director may place any conditions the Director considers reasonable on any Permit.
  - (8) The Director may amend, vary or revoke a Permit at any time.
4. Council has determined that, in consideration of the number of people, the size of the geographic area and the time period affected by the exercise of the powers delegated by Section 3, the said powers are of a minor nature.
5.
  - (1) Permits are required when:
    - (a) the event, activity or function is advertised to the general public with or without an admittance fee;
    - (b) the Park use requirements exceed the existing provision of services or facilities within a Park for hydro, garbage, washrooms and/or event set-up;
    - (c) the Park use is required for a commercial or business activity;
    - (d) the activity includes the serving of food or alcohol, amplification of voice, sound or music or issuance of a license or permit through other regulatory authority.
  - (2) A Permit is not valid unless it is in writing and signed by the Director.
  - (3) A Permit is valid only for the period of time it is granted.
  - (4) A Permit holder shall have the Permit available for review and inspection at all times when exercising the rights granted under the Permit and shall produce the Permit upon the demand of an Officer.
  - (5) Any Person who relies on a Permit has the onus of proving that they were the holder of a valid and subsisting Permit.
  - (6) When a Permit is required, no person shall use a Park without first having paid the applicable fees, if any, or having made the appropriate arrangements for the scheduled payment of fees.
  - (7) Permits issued for activities contemplated in this By-law may be subject to fees as prescribed in the Town's *User Fees, Licensing Fees and Service Charges By-Law*, as amended.
  - (8) Permits issued for activities contemplated in this By-law may include conditions as to the time, location, area, equipment, number of participants, type of activities, release, indemnity and insurance coverage.
  - (9) The issuance of a Permit pursuant to this By-law shall not relieve any person from acquiring the necessary license or permit required from any other government or public authority.
6. No person shall contravene any Permit, restriction or limitation of Park use made by the Director under Part III of this By-law.
7. No Person shall interfere with the use and enjoyment of Persons holding a valid and subsisting Permit for the exclusive use of a Park or portion of a Park, during the times and in the areas for which the Permit is granted.

## **PART IV GENERAL PROHIBITIONS**

**8. No Person shall:**

- (a) enter or remain in a Park between the hours of 11:00 pm and 6:00 am, unless authorized by the Director or by Permit;
- (b) enter into an area in a Park where it is signed to prohibit or restrict admission to the public, except in accordance with the sign;
- (c) dwell, camp or lodge in a Park unless authorized by the Director or by Permit; or
- (d) utilize a Park for any community or special event without the necessary Permit from the Town;

**9. While in a Park, no Person shall:**

- (a) participate in any activity deemed by the Town detrimental to public safety in any area other than those provided for such purpose, or obstruct, interrupt or interfere with any person in the lawful use, enjoyment or operation of the property;
- (b) remove or damage plant materials, trees, shrubs, flowers or turf;
- (c) remove wood, rock, sand, gravel, soil, or other materials;
- (d) add to, alter, maintain or conduct any other activity that would change the existing landscaping of the Park, unless authorized by the Director or by Permit;
- (e) excavate or bury any object;
- (f) create, cause or maintain an open fire, except barbecues or stoves in picnic areas set aside by the Town, unless authorized by the Director or by Permit;
- (g) leave a fire unattended;
- (h) possess, carry or discharge firearms, fireworks, bows and arrows, air guns or any other weapon, but does not include archery events authorized by the Director or by Permit;
- (i) release balloons excepting those made of latex with bio-degradable attachments;
- (j) operate or use any apparatus, mechanism or device for the amplification of the human voice, music or sound, in a manner that disturbs, or is likely to disturb other Persons, unless authorized by Council or by Permit;
- (k) tamper with any Park lighting;
- (l) vandalize or otherwise cause damage to any facility or property, or cause wilful injury to any person or their property;
- (m) leave or deposit any Waste of any kind whatsoever except in the receptacles provided by the municipality for such purposes;
  - (i) in the event that receptacles are not provided, Waste must be removed from the area and disposed elsewhere in an appropriate manner;

- (n) place any Waste whatsoever in a designated recycling receptacle not specified as acceptable for the receptacle.

## **PART V PERSONAL CONDUCT**

**10.** While in a Park, no Person shall:

- (a) engage in conduct that endangers the health and safety of himself, herself or others;
- (b) display riotous or boisterous behaviour, threatening or indecent conduct, expectorate, use profane or indecent language;
- (c) create a nuisance by loitering, spying, leering or annoying anyone or in any way interfere with the use and enjoyment of a Park by other Persons;
- (d) consume, serve or sell alcoholic beverages unless authorized by a Special Occasion Permit issued by the Liquor License Board of Ontario;
- (e) gamble, bet or operate gaming activities;
- (f) urinate or defecate except in a permanent or portable washroom facility;
- (g) enter or be upon a Park premises unless sufficiently clad;
- (h) engage in any sexual activity;
- (i) use a cell phone, camera or any device capable of recording images in change rooms and/or washrooms;
- (j) enter any washroom or change room, or portion thereof set apart for the opposite sex provided that this shall not apply to children who are 6 years of age or younger and who are, at that time, accompanied by a parent, guardian, caregiver or caretaker.

## **PART VI COMMERCIAL ACTIVITIES**

**11.** While in a Park, unless authorized by the Director or by Permit, no Person shall:

- (a) sell, rent, display or offer for sale, any food, drink or refreshment; goods, wares, merchandise including promotional material, souvenirs and novelties, flowers, fruits or vegetables, art, skill, service or work;
- (b) distribute or display signage, notices, or advertisements of any nature;
- (c) solicit, or invite subscriptions or contributions for any trade, occupation, business, profession or charity;
- (d) film, photograph, videotape or televise for commercial purposes without approval from the Town;
- (e) pick worms for commercial purposes.

## **PART VII SPORTS AND ORGANIZED ACTIVITIES**

**12.** While in a Park, no Person shall:

- (a) play or engage in any organized team sport except in those areas designed to facilitate such use;
- (b) ice skate, ice fish, ice sail, ski, snowboard, skibob, sled or toboggan in any Park except in those areas designated for that purpose;
- (c) use a skating rink to race or speed so as to endanger or interfere with any other Person using the rink;
- (d) use a skating rink to engage in hockey or carry or use a hockey stick or similar equipment on a natural or artificial surface which is designated for pleasure skating only;
- (e) bicycle, roller blade, in-line skate or skateboard in any Park where prohibited by posted signs;
- (f) operate radio controlled vehicles, or aircraft, scale model or otherwise;
- (g) ascend or descend in a balloon, airplane or other kind of aircraft or parachute unless authorized by the Director or by Permit;
- (h) play golf or drive a golf ball;
- (i) use a sporting area that has been temporarily or permanently closed;
- (j) engage in an organized sport or activity unless authorized by the Director or by Permit;
- (k) utilize any playing fields for tournaments or special events unless authorized by the Director or by Permit.

## **PART VIII TRAFFIC AND VEHICULAR CONTROL**

**13.** No Person shall:

- (a) park or permit a Vehicle to remain in a Park between the hours of 11:00 pm and 6:00 am, unless authorized by the Director or by Permit;
- (b) park or store or leave a Vehicle in a Park unless actually using the Park;
- (c) park or store or leave a Vehicle in front of a public building, emergency exit, Walkway or entrance to any structure which might in any way interfere with the normal flow of traffic on a Parking Area, Roadway, Walkway, exit or entrance;
- (d) park a Vehicle in an area reserved for holders of valid Park Vendor Permits.

**14.** While in a Park, no Person shall:

- (a) operate or stand or park a Vehicle in a manner causing traffic congestion or a public safety hazard;
- (b) operate or drive within any Park, a public commercial Vehicle as defined in the Public Commercial Vehicles Act except when making deliveries within the Parks;
- (c) drive or operate in a Park a motorized snow vehicle, as defined in the Motorized Snow Vehicles Act R.S.O. 1990, Chapter M44, as amended;
- (d) operate any Vehicle on any areas other than Roadways, Parking Areas, or areas otherwise intended for such use;
- (e) repair or perform maintenance on any Vehicle;
- (f) instruct, teach or coach any person in the driving or operation of a motorized Vehicle;
- (g) ride or drive any animal or operate any Vehicle at a speed in excess of 20 km per hour;
- (h) ride, lead, hitch, fasten or drive any horse or other livestock on any areas other than Roadways, Parking Areas, or areas otherwise intended for such use, unless authorized by the Director or by Permit;
- (i) operate a horse drawn vehicle or sleigh, unless authorized by the Director or by Permit;
- (j) drive, ride or operate a bicycle, roller blades, in-line skates or skateboard where prohibited by posted signs.

**15.** Notwithstanding the provisions of this By-law, Vehicles operated on behalf of an emergency medical service, fire or police department, public utility, Region of Halton, and the Town shall have full access to all parts of the Park at all times where such access is possible.

**PART IX WATER ACTIVITIES**

**16.** While in a Park, no Person shall:

- (a) operate a motorized Boat except by an electric trolling motor, unless otherwise specifically permitted by this By-law;
- (b) operate or ride in a Boat unless wearing certified life jackets or personal flotation device;
- (c) operate or ride in a Boat between sunset and sunrise;
- (d) launch a Boat from any public portion of the shore of Fairy Lake except at the Boat launching ramp provided by the Town within Prospect Park;
- (e) construct or install permanent boat storage facilities;
- (f) dive from a shoreline, dock or Boat;

- (g) encourage, allow or permit any animal to be within a designated Swimming Area;
- (h) damage, relocate, or interfere in any way with lifesaving or emergency equipment or signage installed for public safety and information;
- (i) possess or deposit any glass or metal container within a designated Swimming Area;
- (j) fish within 30.48 m (100 feet) of a designated Swimming Area or in contravention of provincial or federal statutes or regulations;
- (k) operate a boat within a designated swimming area;
- (l) pollute, in any manner whatsoever, or contribute to the pollution of any watercourse in a Park;
- (m) take water for private use outside of the Park;
- (n) enter the fenced area surrounding the Fairy Lake Dam facility;
- (o) swim, bathe or wade in any fountain, pond, lake or stream except in a designated Swimming area;
- (p) contravene any posted rules or regulations relating to the operation or use of a Swimming Area.

## **PART X ANIMALS AND WILDLIFE**

### **17. While in a Park, no Person shall:**

- (a) allow any animal under their control or responsibility to run loose or remain unleashed;
- (b) allow any animal under their control or responsibility to disturb wildlife or damage any Park facility, property or plant material;
- (c) fail to pick up and remove forthwith excrement left by an animal under their control or responsibility and dispose of it in a sanitary manner in a receptacle for litter or in some other suitable container;
- (d) allow any animal under their control or responsibility to enter into a recreation area building unless authorized by the Director or by Permit, or the animal is a Trained Service Animal;
- (e) allow an animal under their control or responsibility to swim or enter into or foul any swimming area or water play feature intended for human use only;
- (f) maim or injure, any bird, animal, waterfowl, or reptile, or interfere with nesting activities;
- (g) feed waterfowl or wildlife.

## **PART XI LEASH FREE ZONES**

18. Notwithstanding any other provisions of this By-law, licensed dogs may be unleashed in an area designated as a Leash Free Zone.
19. Every owner or Person having control of a dog within a Leash Free Zone shall:
- (1) Carry a leash.
  - (2) Immediately remove any animal that displays aggressive behaviour towards people or other dogs.
  - (3) Maintain voice control of the dog and ensure that the animal is within visual sight at all times.
  - (4) Ensure that the dog does not leave the designated area while off-leash.
  - (5) Remove any excrement left by the animal.
  - (6) Obey all rules or regulations posted by the Director relating to the use of a Leash Free Zone.

## **PART XII ENCROACHMENT**

20. (1) Unless authorized by the Director or by Permit, no Person shall encroach on Town owned lands in a Park by any means whatsoever, including but not limited to:
- (a) the construction, installation, maintenance of a fence or structure, permanent or otherwise;
  - (b) the dumping or storage of materials or plantings;
  - (c) the planting, cultivating or grooming of any landscaping;
  - (d) installing or erecting a temporary or permanent tent, structure or shelter;
  - (e) the direct discharge of treated water from a private swimming pool, hot tub or other receptacle into a Park.
- (2) Notwithstanding the provisions in subsection (1) the owner of lands bordering a Park may maintain the turf or natural area in a Park within 1.2m (4ft.) from the abutting property line.

## **PART XIII REGULATION AND ENFORCEMENT**

21. (1) Where any Person in a Park contravenes any provisions of this By-law, such Person is subject to the provisions of *the Trespass to Property Act RSO 1990 Chap. T. 21*, as amended.
- (2) Police officers are hereby authorized to act as agents for the Corporation of the Town of Halton Hills to enforce the *Trespass to Property Act RSO 1990 Chap. T.21, as amended*.

- 22.** Any Officer or employee of the Town designated by the Director to administer this By-law is authorized to inform any Person of the provisions of the By-law and to order any Person believed by such Officer or employee to be contravening this By-law or who has contravened any rules or regulations established by the Director for the management, control, maintenance and usage of a Park:
- (a) to desist from the activity constituting or contributing to such contravention;
  - (b) to remove from the Park any animal, object or thing owned by or in the control of such person which the officer or employee believes is or was involved in such contravention; or
  - (c) to leave the Park.
- 23.** Where any Person contravenes any of the provisions of this By-law, the permission of such Person to remain in that Park or facility is revoked.
- 24.** No Person shall hinder or obstruct, or attempt to hinder or obstruct, an Officer who is exercising a power or performing a duty under this By-law.
- 25.** Any Person who contravenes any provision of this By-law is guilty of an offence and is liable to a fine of not more than \$5,000.00.
- 26.** Every Person who contravenes any provision of this By-law is liable for any damages resulting from the contravention.
- 27.** (1) If the Officer is satisfied that a contravention of this By-law has occurred, the Officer may make an order requiring the Person who contravened the By-law or who caused or permitted the contravention to;
- (a) discontinue the contravening activity, or
  - (b) do work to correct the contravention.
- (2) Any Person who contravenes an order under subsection (1) is guilty of an offence.
- (3) An order under subsection (1) shall set out,
- (a) reasonable particulars of the contravention adequate to identify the contravention and the location of the land on which the contravention occurred; and
  - (b) the date by which there must be compliance with the order.
- (4) An order under subsection (1) may require work to be done even though the facts which constitute the contravention of the by-law were present before the by-law making them a contravention came into force.
- (5) Any work directed or required by the Town under this section, in default of the matter or thing being done by the person directed or required to do it, the matter or thing shall be done at the Person's expense.
- (6) The Town may recover the costs of doing anything or matter under subsection (5) by action or by adding the costs to the tax roll and collected in like manner as taxes.

- (7) The costs in subsection (6) shall include interest calculated at a rate of 15 per cent, calculated for the period commencing on the day the Town incurs the costs and ending on the day the costs, including the interest, are paid in full.

**28.1** A Person who has been issued an order under Section 27, or denied or refused a Permit issued by the Director under Part III of this By-law may appeal to Council by sending a notice by registered mail to the Clerk of the Town within 14 days after being notified by the Town.

**28.2** AMPS By-law – Non-Parking being By-law Number 2025-0008, as amended, applies to this By-law. Every Person who contravenes a provision of this By-law designated in Schedule N of By-law Number 2025-0008, as amended, shall upon the issuing of a penalty notice be and is liable to pay to the Town an administrative penalty in the amount set out in By-law Number 2025-0008, as amended.

#### **PART XIV GENERAL**

**29.** If a court of competent jurisdiction should declare any section or a part of this By-law to be invalid, the remainder of this By-law shall continue in force unless the court makes an order to the contrary.

**30.** That Town of Halton Hills By-laws No. 2003-0025 and 2005-0040 are hereby repealed in its entirety.

**31.** This By-law shall come into full force and effect on its date of passing.
